### EXECUTIVE ORDER NO. FMZ-123 Series of 2022

#### AN ORDER CREATING THE UNIVERSAL HEALTH CARE TECHNICAL WORKING GROUP AND DEFINING THE DUTIES AND FUNCTIONS THEREOF

**WHEREAS**, the Local Government Code in Section 102 provides that the local health board, consistent with the technical and administrative standards of the Department of Health, shall create committees which shall advise local health agencies on matters such as, but not limited to, personnel selection and promotion, bids and awards, grievances and complaints, personnel discipline, budget review, operations review and similar functions;

**WHEREAS,** the Universal Health Care Act integrates the local health system into city-wide health system to ensure the effective and efficient delivery of population-based and individual-based health services;

**WHEREAS,** the Sangguniang Panlungsod approved City Resolution No. 71, series of 2022 in support of the intent of the City Government of San Juan to be part of the Integration Site of the implementation of Universal Health Care;

**WHEREAS,** City Resolution No. 83, series of 2022 authorized the City Mayor to enter into a Memorandum of Understanding for and in behalf of the City Government of San Juan for the implementation of the Universal Health Care Integration Sites;

**WHEREAS,** in the commitment of the City of San Juan to the implementation of the Universal Health Care Act, it is necessary to organize and create a San Juan Universal Health Care Technical Working Group ("SJUHC-TWG");

**NOW, THEREFORE,** I, **FRANCISCO JAVIER M. ZAMORA**, Mayor of San Juan City, by virtue of the powers vested in me by law, do hereby order the following:

**SECTION 1. Creation and Mandate.** The San Juan Universal Health Care Technical Working Group ("SJUHC-TWG") shall be implementing the Universal Health Care Act in the City of San Juan as one of the integration sites in Metro Manila;

## SECTION 2. Composition. The SJUHC-TWG shall be composed of following:

**SECTION 3. Duties and Functions.** The UHC-TWG shall perform the following specific duties and responsibilities, but not limited to:

- a) Coordinate with different sectors involves in the UHC implementation and ensure that UHC policies are implemented;
- b) Assess the implementation of the UHC program as the implementation integration site in the City;
- c) Identify and establish the roles and responsibilities of the partners in the organization and delivery of the Universal Health Care Act;
- d) Oversee the functionality of the UHC provider network in the full implementation of the Universal Health Care Act;
- e) Formulate policies regarding the program;
- f) Ensure the delivery of the promotive, preventive, curative, rehabilitative, and palliative components of health care within the City of San Juan;
- g) Ensure the commitment of the health system stakeholders of San Juan City, including, among others, patients and residents and their representatives, healthcare workers, the academe, and development partners;
- h) Conduct preparatory work needed to facilitate local health system integration, such as but not limited to, operational guidelines, baseline studies, training needs assessment, participatory, evidence-formed development of local investment plan of health;

- i) Create executive orders or ordinances that will facilitate the realization of the integration outputs and outcomes of the UHC;
- j) Conduct meetings and forums;
- k) Prepare plans; and
- I) Implement and evaluate activities.

**SECTION 4. Repealing Clause** – all orders, rules and regulations or parts thereof which are inconsistent with the provisions of this Executive Order are deemed repealed, amended or modified accordingly.

**SECTION 5. Separability Clause. -** If for any reason, any provisions of this Order are declared invalid or unconstitutional, the remaining provisions not affected thereby shall continue to be in force and effect.

**SECTION 6. Effectivity.** This order shall take effect immediately upon signing hereof and remains effective and binding unless revoked, repealed or modified.
