AN ORDINANCE AUTHORIZING THE TRANSFER OF ONE MILLION FIVE HUNDRED THOUSAND PESOS (P1,500,000.00) FROM THE LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND (LDRRMF) OF THE CITY OF SAN JUAN, METRO MANILA TO THE PROVINCE OF ILOCOS NORTE AND FIVE HUNDRED THOUSAND PESOS (P500,000.00) TO THE PROVINCE OF ILOCOS SUR, RESPECTIVELY

WHEREAS, Super Typhoon Egay brought about strong winds and heavy rains causing floods that affected provinces in Luzon on July 25 to July 27, 2023;

WHEREAS, the Sangguniang Panlalawigan of Ilocos Norte has declared the entire province under a state of calamity due to the severe flooding and strong winds brought about by Typhoon Egay through Resolution No. 169-2023 dated July 26, 2023;

WHEREAS, the Sangguniang Panlalawigan of Ilocos Sur has declared the entire province under a state of calamity due to the severe flooding and strong winds brought about by Typhoon Egay through Resolution No. 0364, Series of 2023 dated July 26, 2023;

WHEREAS, based on initial/progressing report of the Provincial Disaster Risk Reductions and Management Councils (PDRRMC) of Ilocos Norte and Sur, there are hundreds of millions of pesos worth of damages to agriculture, infrastructure and other properties, including a number of residents who were rendered homeless due to the effects of the typhoon;

WHEREAS, the City Disaster Risk Reduction and Management Council (CDRRMC) has recommended to transfer from the Local Risk Reduction and Management Fund (CDRRMF) of the City of San Juan, Metro Manila to support the Provincial Disaster Risk Reduction and Management Fund (PDRRMF) of the Province of Ilocos Norte through CDRRMC Resolution 2, Series of 2023 and Provincial Disaster Risk Reduction and Management Fund (PDRRMF) of the Province of Ilocos Sur through CDRRMC Resolution 3, Series of 2023

WHEREAS, both cities have shared special ties for many years and it is but necessary to extend assistance most especially in times of calamity and distress;

WHEREAS, under R.A. No. 10121, Section 21 authorizes the transfer of funds subject to the approval of the CDRRMC and the Sangguniang Panlungsod.

NOW THEREFORE BE IT ORDAINED AS IT IS HEREBY ORDAINED, by the Sangguniang Panlungsod of the City of San Juan, Metro Manila, in a session duly assembled, THAT:

SECTION 1. To authorize the transfer of One Million Five Hundred Thousand Pesos (P1,500,000.00) from the Local Disaster Risk Reduction and Management Fund (LDRRMF) of the City of San Juan, Metro Manila to the Province of Ilocos Norte and Five Hundred Thousand Pesos (P500,000.00) to the Province of Ilocos Sur.

SECTION 2. The City Mayor is authorized to sign any and all documents in connection with the transfer of funds, subject to compliance with Section 4 hereof.

SECTION 3. The City Treasurer is hereby authorized to release the funds subject to the availability of funds and must be in compliance with Section 4 hereof.

SECTION 4. The issuance and approval hereof is subject to compliance by all concerned with all existing laws, circulars, and rules and regulations on allocation, transfer, releases and disbursement of the LDRRMF.

SECTION 5. This Ordinance is effective upon approval hereof.




