A RESOLUTION AUTHORIZING HONORABLE CITY MAYOR, HONORABLE FRANCISCO JAVIER M. ZAMORA, TO ENTER INTO A MEMORANDUM OF UNDERSTANDING (MOU) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF SAN JUAN AND POLYTECHNIC UNIVERSITY OF THE PHILIPPINES (PUP), REPRESENTED BY DR. MANUEL M. MUHI, ASEAN ENGR., UNIVERSITY PRESIDENT, FOR THE IMPLEMENTATION OF THE PARTNERSHIP INITIATIVE OF THE UNIVERSITY THROUGH THEIR FLAGSHIP PROGRAM SALIN-KAALAMAN TUNGO SA KAUNLARAN AND TO SERVE THE BEST INTEREST OF THE PARTIES IN TERMS OF CAPACITATION AND IN ACCORDANCE WITH PROFESSIONAL STANDARDS, SUBJECT AND CONDITIONED UPON COMPLIANCE TO ALL EXISTING LAWS, CIRCULARS, RULES AND REGULATIONS

WHEREAS, one of the objectives of the PUP is to extend its expertise to its target beneficiaries or communities through extension service by the Office of the Vice President for Research, Extension, Planning and Development- Extension Management Office (EMO) and the City Government of San Juan to implement the Salin-Kaalaman Tungo sa Kaunlaran Project;

WHEREAS, the PUP has chosen the City Government of San Juan as its extension partner through which the City Government of San Juan may tap qualified faculty members and graduate students of the PUP, where the latter will serve as consultants, resource speakers, reviewers and/or trainers to conduct trainings and other relevant activities to help improve the quality of life of the constituents of PUP;

WHEREAS, the City Government of San Juan has signified its intention to partner with PUP on collaborative undertakings and area where the expertise of the PUP shall be utilized, subject to pertinent policy and guidelines of both PUP and the City Government of San Juan;

WHEREAS, the City Government of San Juan recognizes the efforts in addressing the needs of its participants on adequate trainings given the PUP;


WHEREAS, both the City Government of San Juan and PUP have agreed to implement partnership initiatives to serve the best interests of each other in terms of capacitation, and in accordance with professional standards;

WHEREAS, the City Legal Officer, has reviewed the pertinent documents related to this matter and has duly certified that the Memorandum of Understanding is in good order and not contrary to existing laws, circulars, rules, and regulations and that the City Mayor may sign the same.
