A RESOLUTION AUTHORIZING HONORABLE CITY MAYOR, FRANCISCO JAVIER M. ZAMORA, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF SAN JUAN WITH THE POLYTECHNIC UNIVERSITY OF THE PHILIPPINES (PUP), REPRESENTED BY DR. MANUEL M. MUHI, FOR THE IMPLEMENTATION OF THE JOINT CUSTOMIZED GRADUATE PROGRAM LEADING TO THE DEGREES OF MASTERS IN PUBLIC ADMINISTRATION (MPA) AND THE UNDERGRADUATE PROGRAMS IN BACHELOR OF SCIENCE IN INFORMATION TECHNOLOGY AND BACHELOR OF SCIENCE IN OFFICE ADMINISTRATION FOR THE YEAR 2023-2024, SUBJECT AND CONDITIONED UPON COMPLIANCE TO ALL EXISTING LAWS, CIRCULARS, RULES AND REGULATIONS.

WHEREAS, the Polytechnic University of the Philippines (PUP), a chartered state institution of higher learning, is mandated to provide professional occupational and technical instruction and training in the applied arts and science, and take steps to enrich the academic programs in other allied fields of study by integrating such courses that are necessary to produce individuals with highly professional, managerial, and technical skills and promote applied research, advanced studies, and progressive leadership in the above-stated fields;

WHEREAS, Article XIV, Section 1 of the 1987 Constitution states that the State shall protect and promote the right of all citizens to quality education at all levels and shall take appropriate steps to make such education accessible to all;

WHEREAS, City Ordinance No. 6, Series of 2008 established a PUP Annex in the City of San Juan;

WHEREAS, the Local Government of San Juan, in line with its mandate to provide program for human resource development, recognizes the need to upgrade and strengthen the capability of city personnel and has established a continuing education program for the city government employees;

WHEREAS, PUP, being an educational institution offering courses in various disciplines and capable of conducting postgraduate, as well as undergraduate studies, is willing to accommodate the City Government of San Juan's Continuing Education Program;

WHEREAS, in view of the principles stated above, the LGU and PUP have agreed to work together to establish and implement a customized undergraduate and postgraduate Continuing Education Program for the benefit of the City Government of San Juan employees;

WHEREAS, the City Legal Officer has reviewed the pertinent documents related to this matter and has duly certified that the Memorandum of Agreement is in good order and not contrary to existing laws, circulars, rules, and regulations and that the City Mayor may sign the same.

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, BY THE SANGGUNIANG PANLUNGSOD OF THE CITY OF SAN JUAN, AND BY VIRTUE OF THE POWERS VESTED IN IT BY LAW, in a session duly assembled, to authorize the Honorable City Mayor to enter into a Memorandum of Agreement with PUP for the implementation of the joint customized graduate program leading to the degrees of Masters in Public Administration (MPA) and the undergraduate programs in Bachelor of Science in Information Technology and Bachelor of Science in Office Administration for the year 2023-2024.

RESOLVED FURTHER, that the authority, issuance and approval hereof is subject to certain restrictions and to all existing laws, circulars, rules and regulations.


