**DECLARATION OF A WEEK-LONG CITY-WIDE MOURNING IN THE
CITY OF SAN JUAN TO PAY RESPECT AND MOURN THE PASSING OF
HON. JOSE WARREN P. VILLA**

WHEREAS, it is with profound sadness and deep sorrow that we mourn the untimely passing of Honorable Vice Mayor Jose Warren Villa on June 18, 2023, an esteemed public servant and dedicated member of our community;

WHEREAS, Vice Mayor Villa's commitment to public service, tireless efforts, and unwavering dedication to the City of San Juan have left an indelible mark on our community, and his loss is deeply felt by all those who had the privilege of knowing him;

WHEREAS, in recognition of Vice Mayor Villa's significant contributions to the City of San Juan and his unwavering commitment to improving the lives of its residents, it is fitting to honor his memory by declaring a period of mourning throughout the city;

WHEREAS, pursuant to the Implementing Rules and Regulations ("IRR") of Republic Act No. 8491, otherwise known as the "Flag and Heraldic Code of the Philippines", the National Flag shall be flown at half-mast as a sign of mourning on all the buildings and places where it is displayed on the day of the official announcement of the death of City Vice-Mayors for three (3) days; "half-mast" shall mean lowering the flag to one-half the distance between the top and bottom of the pole;

NOW THEREFORE, by virtue of the powers vested in me by law, I, **FRANCISCO JAVIER M. ZAMORA**, Mayor of the City of San Juan, do hereby promulgate, as follows:

SECTION 1. City-Wide Mourning Period

(a) A week-long period of mourning shall be observed throughout the City of San Juan to honor the memory of Honorable Vice Mayor Jose Warren P. Villa from 19 June 2023 to 25 June 2023.

(b) All Philippine National Flags in the territorial jurisdiction of the City of San Juan to be flown at half-mast to pay respect and mourn the passing of the Honorable Vice Mayor for a period of three (3) days from 19 June 2023 to 21 June 2023.

(c) All official city events and celebrations shall be suspended for the duration of the mourning period, as a mark of reverence and remembrance for Vice Mayor Villa.

SECTION 2. Repealing Clause. - All other issuances or orders, or part or parts thereof, which are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.

SECTION 3. Separability Clause. - If for any reason, any provisions of this Order are declared invalid or unconstitutional, the remaining provisions not affected thereby shall continue to be in force and effect.

SECTION 4. Effectivity. This order shall take effect immediately upon its approval.
